About the Award

The Chamber Executive of the Year Award is presented to an individual who has exhibited characteristics that make him or her a leader both in their Chamber of Commerce and community.

The award is based on the demonstration of excellence in <u>outstanding accomplishments</u>, <u>effectiveness</u> <u>in addressing challenges</u>, <u>professionalism</u>, <u>program development and implementation</u>, <u>fiscal</u> management, and stature in the community.

The award encourages <u>nomination of chamber executives by the chamber's board leadership, the executive's staff, and/or peers of the chamber executive</u>.

Eligibility

CEO-level members of VACCE in good standing are eligible to receive the award.

Benefits to Award Recipients

- Listing on the VACCE website and various other announcements to VACCE members;
- Recognition via an official VACCE press release; and
- A plaque presented at the Awards Ceremony for display at executive's chamber.

Applications and Deadlines

Nomination requirements include:

- o Completion of the **nomination application**;
- Recommendation letter of nominee (including examples of executive's demonstration of excellence in prescribed areas);
- o Business Plan / Program of Work for your Chamber; and
- o A biographical sketch or resume of nominee along with photo.

Deadline for award applications is 5:00pm on Friday, May 24, 2019.

 - **Challenges** note your executive's effectiveness in addressing recent major challenges before your Chamber or the area it serves;
 - **Professionalism** cite examples of your executive's recent efforts to enhance his/her ability to better serve your Chamber and community;
 - Program Development what innovative actions has your executive used to develop a meaningful Business Plan / Program of Work for your Chamber;
 - **Fiscal Management** how is your Chamber addressing the short and long-term financial support required to accomplish your Business Plan / Program of Work;
 - **Community Presence** in what ways is your executive involved with and serving the community beyond his/her position with your Chamber; and
 - **Special Qualities** be sure to include any special qualities your executive brings to his/her work.
